# EASTERN MARKET COMMUNITY ADVISORY COMMITTEE REGULAR MEETING MARCH 27, 2024

#### **MINUTES**

Attendance: Mike Bowers (for Bill Glasgow); Nikki Dean Brown; Chuck Burger, Chair; Monte Edwards, Secretary; Steve Hagedorn; Jackie Krieger, Vice Chair; and Jerry Sroufe.

The regular meeting of the Eastern Market Community Advisory Committee (EMCAC) was held on Wednesday, March 27, 2024, at 7:00 P.M., in person in the North Hall and via Zoom. The Chair called the meeting to order at 7:05 P.M.

### **Adoption of the Agenda**

The agenda was adopted as distributed.

## **Approval of the Minutes**

The minutes of January 31, 2024, were approved.

#### **Report of the Chair**

The Chair noted the excused absences of Tom Kuchenberg, Treasurer, and Brian Pate and requested that EMCAC members keep him informed on whether they are able to attend each EMCAC meeting. The Chair reported on behalf of the Treasurer that the bank account balance is unchanged. The Chair also reported on the following topics.

- Rumsey Pool Project: \$25 million has been set aside for the nascent project. Documents are being developed for holding community meetings, which will occur several months from now. EMCAC likely will hold community meetings on the project in about six months.
- Department of General Services (DGS) Director Hunter: The Chair has been in contact with DGS Director Hunter and plans to schedule a meet and greet-type event with EMCAC and the Director.
- Invitations to Councilmembers: This effort has been delayed by the budget process.
- Update on Ad Hoc Subcommittee on Communications: The Chair has interviewed two interested individuals. More volunteers are needed for the subcommittee, and the Chair requested that the representatives of organizations on EMCAC inquire within those organizations for volunteers to serve on the subcommittee.

## **Report of the Subcommittee on Capital Improvements**

Mr. Edwards, Chair of the Subcommittee on Capital Improvements, reported that he is monitoring when the city budget will be publicly available and the latest information he has received from Council Chairman Phil Mendelson is April 1. Of concern to EMCAC is ensuring funding in the budget that will allow the chilled water and hot water piping to be replaced. These systems continue to operate without water treatment and, therefore, the piping continues to corrode, affecting the functioning of the values and controllers. As a result, Barry Margeson, Market Manager, must operate the system manually.

#### **Report of the Market Manager**

Mr. Margeson presented a written report, which is attached to these minutes. Mr. Margeson introduced Alejandra Calvache, a Youth Leader through the Youth Leaders of the Americas Initiative State Department Program, who gave brief remarks. He agreed to find out for the next meeting where and when bollards will be installed and contact Marshall Retail Group regarding the curation of Eastern Market products. Ms. Calvache made a presentation on a draft Eastern Market marketing plan, which also is attached to these minutes.

Bollards: The bollards that were specified in the plan are no longer available and the alternative products are more expensive. The General Contractor has engaged with Concentric Security who did the original analysis. They proposed that the bollards be placed at the high risk locations for phase 1: 7<sup>th</sup> and North Carolina, 7<sup>th</sup> and Pennsylvania, C and the alley. I will provide the proposal to the security committee.

Work has begun on stonework (order placed), elevator, fire alarm, and security system.

**Advisory Review Subcommittee:** We're working closely together. Next month, we'll have status of accepted vendors as we've had in the past.


## **Security Update:**
